ANNOUNCEMENT:

NG Road Racing Club will hold a Classic Parade at Castle Combe, under the above Permit granted by the ACU. The Meeting is held under the National Sporting Code and Standing Regulations for Road Races (Section 20.4 – PR6 Classic Machine and / or Rider Parades), and these Supplementary Regulations.

THE COURSE:

The Course is 12 metres wide and 1.85 miles in length. Direction of travel is clockwise. Maximum number of starters: 72.

ELIGIBILITY (Rider and Machine):

Riders must be between 18 and 70 years of age and hold a current ACU or SACU Road Race or Parade Licence or a Class A DVLA Motorcycle Licence, which must be presented to the Secretary of the Meeting when signing on. Holders of licences issued by any FMN other than the ACU or the SACU must have insurance and start permission from the relevant FMN. This insurance must include the FIM Standard Repatriation evidence of such insurance and start permission will need to be seen by the Secretary of the Meeting. Machines must be Classic race or sports machines presented in a clean and safe condition equipped with racing number plates and displaying the allocated riding number. Protective clothing and helmets must be in accordance with the Road Race Standing Regulations.

ENTRIES and ENTRY FEE:

The Club reserves the right to refuse entry, abandon, cancel or postpone the Meeting or alter the programme of events. Entries should be submitted on the Official Entry Form and sent to the address shown on the form. Only in exceptional circumstances will entry fees (less an Administration charge of £15.00) be refunded – no refunds will be considered unless the Secretary of the Meeting is notified in writing at least two days prior to the meeting and the entry passes returned therewith. NG Road Racing reserve the right to cancel this Parade should there be insufficient Entries.

Entry fee: The entry fees for this Classic Parade is £xx. Cheques and credit card payments will be taken 2 weeks prior to meeting.

INSURANCE:

The Organisers undertake to insure each driver and passenger, indemnifying them against any third party claims arising out of the races or official practice, excluding claims by other drivers or passengers, entrant, sponsor, or mechanic, in accordance with the scheme of insurance set out in the 2013 ACU Handbook.

TECHNICAL INSPECTION & SIGNING ON:

From 09:00 following on from Race Machine Inspection. Riders are to present their machine and themselves for inspection fully clothed in their Leathers, Boots, gloves and Helmet.

PROGRAMME OF EVENTS:

The normal Race Programme will commence as soon as practice is complete. The two 15 minute parades will take place during the lunch interval and one other time (tba) and will be detailed in the race day programme.

NB Due to the compact nature of the Programme, the timing of the break is subject to change depending on race activity. Paddock Tannoy announcements will be made to confirm timings.

Static Display - each rider is encouraged to display an information board about his machine and to advise and encourage spectators.

RIDERS BRIEFING:

A compulsory riders briefing will be held at 10am in the Technical Inspection area.

START OF PARADES

Riders should be in the Assembly Area 10 minutes before the parades take place. Machines will be released onto the circuit in groups controlled by Pit Lane officials. The Parade will be terminated by the waving of the chequered flag.

ADMISSION:

Each entrant will receive three personal passes. ALL extra persons arriving with a competitor will be charged admission. Off track, there is a strict speed limit of 20mph. Animals are NOT permitted at any time. Whilst we welcome children and families, children must be supervised at all times and are prohibited from riding bicycles and scooters in the paddock whilst the race circuit is live.

COURSE CONDUCT:

Riders must only enter and leave the circuit at designated points. Riding of motorised paddock bikes, is prohibited. Crash helmets must be worn at all times while riding. Dangerous riding or unsporting conduct will result in disqualification and / or a fine. **Under 16 year olds, unless a competitor, are not permitted in the pit lane.**

PHOTOS:

By taking part in this meeting you accept that photographs may be taken for promotional purposes and used on the NG Road Racing Club website or NG Road Racing Club promotional materials.

NOISE TESTING:

All machines will be noise tested prior to joining the circuit for practice.

DECLARATION AND INDEMNITY

ALL RIDERS, PASSENGERS AND GUARDIANS (where appropriate) MUST SIGN BELOW.

ENTRY DECLARATION: I the undersigned apply to enter the event described above and in consideration thereof: -

- I hereby declare that I have had the opportunity to read, and that I understand the National Sporting Code of the ACU, the ACU Standing Regulations, such Supplementary Regulations as have or may be issued for the event, and agree to be bound by them.
- I further declare that I am physically and mentally fit to take part in the event and I am competent to do so. I confirm that I understand the nature and type of event I am entering and its inherent risks and agree to accept the same notwithstanding that such risks may involve negligence on the part of the organisers or officials.
- I accept that insurance arranged on my behalf by the organisers of events that I may enter specifically excludes liability between the participants. I understand that this form may be used in litigation as evidence that any serious injury will be principally the result of my voluntary decision to engage in a high risk activity.
- I consent to details of any injuries I may suffer at this event being passed between all medical services and the Clerk of the Course.
- I consent to the collection and retention of my personal information by the ACU.
- I confirm that the machine(s) as described below which I shall participate on shall be suitable and proper for the purpose. I confirm that I am eligible to participate on the machines for which I have entered.
- I confirm that if any part of the event takes place on a public highway, the machine(s) described below shall be insured as required by the Road Traffic Acts, or equivalent legislation, and that they will comply with the regulations in respect thereof.
- I accept responsibility for any items borrowed from the Organiser during the course of the event. These items include but are not restricted to (safety clothing, transponders, accessories). I understand that I am liable for the cost or replacement of any items lost or not returned and non-payment or non-replacement of items borrowed may affect my entry into subsequent events.
- I confirm that I have not been refused an ACU Licence, nor had an ACU Licence suspended, nor have I been excluded from any ACU competition.

ACKNOWLEDGEMENT OF THE RISKS OF MOTORSPORT: I understand that by taking part in this event I am exposed to a risk of death, becoming permanently disabled or suffering some other serious injury and I acknowledge that even in the event that negligence on the part of the ACU, any event organiser, any circuit owner, the promoter, the organising club, the venue owner, or any individual carrying out duties on their behalf were to be a contributory cause of any serious injury I may suffer, the dominant cause of any serious injury will always be my voluntary decision to take part in a high risk activity.

I have read the above and acknowledge that my participation in motorsport is entirely at my own risk. I agree that I am required to register on arrival by "signing on" at the designated place before taking part in any Practice Session or Race.
