



GENERAL TESTING REGULATIONS

MOTOR SPORTS CAN BE DANGEROUS AND MAY INVOLVE INJURY OR DEATH

ALL PARTICIPANTS MUST READ THE FOLLOWING REGULATIONS AND CONDITIONS & AGREE TO BE BOUND BY THEM & THE TRUTH OF THE STATEMENTS AS TO YOUR COMPETANCY TO PARTICIPATE IN THIS ACTIVITY AND REGULATION "F" & SIGN THIS DOCUMENT.

REGULATIONS.

- A. All participants must sign on and / or agree to the following rules and regulations. Signing on creates a legally binding relationship in return for your being allowed to participate.
- B. When signing on to participate in testing activities you confirm that you have read and can satisfy yourself that you can comply to the following:
- C. I will satisfy myself (by sighting lap or otherwise) before taking part that the venue and track is acceptable to me with regard to its features and physical layout (unless prohibited to do so).
- D. By taking part I accept the risks involved including the risk of injury or death.
- E. I declare that I am competent to take part.
- F. I declare that my vehicle is safe, complies with the regulations and is fit to use for the activity for which I have attended today.
- G. I am aware and accept that other participants will be on the course at the same time.
- H. I am not taking any drugs (Prescribed or otherwise) that will impair my ability to take part.
- I. I have read, understood & will comply with all circuit regulations, any supplemental regulations & final instructions for this event given by the organiser and/or venue owner.
- J. If under the age of 18, my parent/guardian has read the above and signed a declaration to confirm their agreement for my participation in the event and the rules & regulations agreed to by me written or verbal.
- K. I am aware of the signals that may be used whilst on the circuit, as laid down in the ACU / MSUK handbooks, and agree to abide by the standard written or verbal conditions laid down by BARC (Pembrey) Ltd Circuit staff etc. whilst attending the venue.
- L. The circuit operates in a clockwise direction.
- M. Entry to the circuit is via the Assembly situated at the top end of the paddock area. [Unless otherwise directed.]
- N. Vehicles leaving the circuit during or at the end of a session should do so through the Pit Lane Entrance unless otherwise instructed by the Marshals or officials.
- O. Any vehicle that may encounter a problem during a session should leave the track in a safe manner. Any vehicle that cannot continue under its own power should be parked off the track as safe as possible and the driver /rider should leave the vehicle and make themselves safe behind the barriers and wait for instruction from an official.
- P. Any participant who is not sure on any of the above regulations should contact race control for further clarification.
- Q. No passengers will be carried in any vehicle except sidecars.
- R. During participation I shall wear clothing suitable for my discipline as laid down by the MSUK or ACU current regulations.

GENERAL CONDITIONS

- Riders / Driver's** Must hold a current FIA / FIM, MSUK / ACU competition licence or ARDS certificate. Which, is the required grade for the vehicle they wish to test.
BARC (Pembrey) Ltd may make exemptions in special cases.
- Motorcycle's/ Car's** Must be silenced and comply with MSUK / ACU current racing, circuit and safety requirements, the vehicle is safe, complies with the regulations and is fit to use for the activity for which, it is to be used.
Minimum age 12. Such participants may be required to satisfy the organisers as to their competency to participate in the activities
- Times** Signing on from 07.00am Testing sessions 09.00am to 17:00pm. Normally 15 Min. Sessions.
All of the above times are subject to daylight & weather conditions.
BARC (Pembrey) Ltd and its employees will endeavour to operate to these conditions, but have the right to change them at any time without notice.

CIRCUIT CONDUCT

Racing or driving too close to other vehicles is not permitted. Timing (or signalling of times) and cameras are also not permitted.

PHOTOGRAPHS

Photography at the circuit is prohibited unless for personal purposes only. You are not permitted to sell photographs that you take and that they are not used for promotional or commercial purposes. You must have the consent of the circuit first.

NOISE RESTRICTIONS

Any vehicle to be used on the circuit must pass a noise test on the day. Depending on the format of the day it should not exceed 98dba. Testing procedures are DRIVE BY TESTING. Refunds cannot be offered should your vehicle fail.

Drivers, riders and passengers must:

- 1 Read and sign and / or agree with the **General Testing Regulations, Terms & Conditions** before taking to the track.
- 2 Wear a wristband (or appropriate signifier) denoting the **Circuit Driving Rules and Declaration** have been read and signed
- 3 Wear a suitable approved **ACU / MSUK motorsport helmet**
- 4 Wear suitable footwear / Clothing as per **ACU / MSUK Regulations**.
- 5 Wear a seat and head restraint as per **MSUK Regulations. (Cars only)**
- 6 Not drive or ride while under the influence of alcohol or intoxicating drugs
- 7 Not smoke in the pits or on the circuit – it is a fire risk
- 8 Not eat, drink or chew gum on the circuit

Remember:

- 1 Please supervise children carefully
- 2 Do not exceed 15 mph on any service road or in the paddock
- 3 Refuel only in the designated area
- 4 Cold tyres have less grip, so drive carefully for at least the first couple of laps to warm your tyres.

DECLARATION AND AGREEMENT

The following Declaration and Agreement is to be signed by every participant, guest and/or invitee before the commencement of the "purpose". In consideration of being allowed to take part in this event I declare and accept: -

1. That B.A.R.C. (Pembrey) Ltd. will not be scrutineering participants' vehicles before permitting them on the track.
2. That I am competent to take part in the event.
3. That I am fit and healthy and my eyesight (with lenses if to be worn) is adequate for track use.
4. That any vehicle for which I am responsible and which will be used on the track is in good and suitable condition and fit for its purpose.
5. I confirm that I hold a Current Competition licence to rider / drive the vehicle I will use.
6. That I will not participate whilst under the influence of alcohol or intoxicating drugs
7. That I will comply with the rules as set out in this document, as well as any rules communicated to me by track marshals, officials or any person involved in the organisation of the event
8. That I myself am responsible for the way in which I use the track.
9. **Inspection of Circuit:** Before taking part in the event, I will ensure that I have inspected the venue, the track and the facilities and geographical features and that I am satisfied that it is safe for me to participate. I will NOT take part if I have any doubt about my ability or the safety of the venue.
10. **Acceptance of Risk:** I accept by entering and signing on that motor sport may involve the risk of injury or death and I agree to take part at my own risk. Before taking part in the event, I will read and be bound by and comply with any general regulations, supplemental and final instructions issued by the regulatory bodies (if applicable) the organisers and the Circuit Owners.
